Consistent with the organization's mission, each year grants are awarded through a grant application process from the organization's endowment funds in accordance with the organization's spending policy and the wishes of the donors.

The organization's second program is our Scholarship Program. Each year scholarships are awarded from Field of Interest endowed and nonendowed funds to various students meeting the qualifying criteria set forth in the fund documents. The scholarship committee, along with donor selection committees, review the applications and recommend the acceptable recipients. Finally the board of trustees approves the scholarships and the scholarships are awarded.
